

## **Terms and Conditions for Empanelment of Valuers**

### **1. Purpose**

Kumari Bank Limited proposes to empanel valuers for carrying out valuation of following classes of assets:

- (i) Land & Building (L&B); and
- (ii) Plant & Machinery (PM)
- (iii) Vehicles

### **2. Minimum Eligibility Criteria & Requisite Documentary Proof**

The minimum eligibility criteria for various classes of asset are provided in Annexure-A. The Documentary Proof acceptable against each eligibility criteria is provided in Annexure-B.

### **3. Application Submission Guidelines and Selection**

The application shall be submitted in accordance with the following guidelines:

- (i) Deadline for submission of application is 15 days from the date of publication of notice.
- (ii) One Applicant shall submit only a single application.
- (iii) Application shall be strictly submitted in the format prescribed in Annexure-C. Non-compliance of the prescribed format may lead to rejection of the application.
- (iv) Any complete application received after the above mentioned cut-off date shall not be considered for current process of empanelment but may be acknowledged for consideration in future process.
- (v) The applicant shall make a payment of non-refundable application fee amounting to NPR 5,000.00 (Nepalese Rupees five thousand only) by making deposit in Miscellaneous Deposit Receipt (MDR) in any branch office of Kumari Bank Limited along with the application.
- (vi) All the information/details are to be supported by authentic documents duly certified by the Applicant.
- (vii) Applications shall be submitted in a sealed envelope titled 'Application For Empanelment of Valuer' to Credit Administration and Control department at Head Office, Naxal, Kathmandu or any one of the branch offices. The list of branch offices is available on the bank's website.
- (viii) The valuers presently empaneled with the Bank shall also require to apply fresh and the existing panel will cease to exist on approval of the new panel.
- (ix) The Bank's decision on selection shall be final and no communication in that respect shall be entertained.
- (x) The selected valuers will be notified through email.

### **4. Empanelment Period**

The selected valuers shall execute agreement and other documents and furnish acceptable performance indemnity bond. On execution of documents shall be empaneled for a period of 2 years. However, a review exercise may be made periodically based on performance along with necessary information. Kumari Bank

Limited reserves its right to de-list the name of the consultant at any stage, if found unsatisfactory or does not comply with the KBL's requirement.

## Annexure – A

### Eligibility criteria

1. The firm/ company must be registered with the appropriate body(ies) of the GON and have duly filed its tax returns and/ or renewed its registration.
2. Must have PAN and/or VAT registration.
3. The proprietor/ partner/ lead/ key person(s) of the firm/ company should possess the following qualifications and work experience:

Educational Qualification	Work Experience
At least Bachelor's degree in civil engineering/ architecture / mechanical engineering (for plant & machinery and vehicles).	At least 5 years work experience in the field of valuation after completion of the degree or equivalent.

4. The firm/ company must have been listed in the panel of valuers with at least 3 A class commercial banks for the past 2 consecutive years.
5. The firm/ company and its lead person(s) must not be blacklisted.
6. The firm/company and lead/ key person(s) must not be the borrower of Kumari Bank Ltd.
7. The firm/ company must not have been delisted/ removed from the services due to misconduct.
8. The firm/ company must have adequate number of engineers specialized in civil, mechanical engineering and qualified and experienced surveyor(s)/ valuer(s) including land surveyor(s).

## **Annexure – B**

### **Acceptable documentary proof**

The following papers/documents are required to be furnished by the interested Valuer(s) to the Bank for enlistment:

1. Application for empanelment of valuer (Annexure – C).
2. Profile of the firm/ company, which shall include the following:
  - Copy of Certificate of Registration of the Company/Firm. In case of proprietorship/ partnership firm, evidence of renewal of registration.
  - Copy of PAN and/or VAT registration certificate.
  - Copy of Memorandum & Articles of Association duly registered with the Office of Company Registrar, with amendments, if any (In case of Company).
  - Resolution of the company's Board/Firm for enlistment and giving authority to sign all the papers, documents indemnity, report/certificate etc. on behalf of the Company/Firm.
  - Copy of Income Tax Clearance Certificate (recent past FY).
  - Curriculum Vitae (CV) of the lead/ key Engineers as well as other engineers and surveyors/ valuers.
  - Copy of citizenship certificate of lead/ key persons/ engineers.
  - Copy of academic certificates.
  - Copy of certificate issued by Nepal Engineering Council.
  - Experience/ recent reference Certificate of the firm/company issued by other commercial banks where the interested consultant is in the approved panel of valuers.
  - Report of Karja Suchana Kendra Ltd. showing clean status.

All of the above documents must be bound together and submitted along with the application.
